- \_\_\_ 1. Eye and ear protection must be worn at all times.
- \_\_\_ 2. Drug and Alcohol use is strictly prohibited including the odor on person.
- \_\_\_ 3. All rental firearms entering or leaving the range area must be **UNLOADED** with actions open and magazines removed from firearm.
- \_\_\_ 4. Personal firearms must be unloaded and cased, or with current CPL, holstered and concealed, until at station on the range.
- \_\_\_ 5. Firearm muzzles must be pointed downrange at all times and **NEVER HIGHER THAN THE TARGET.**
- \_\_\_ 6. Unaimed and uncontrolled fire is strictly prohibited. All shots must be fired at approved targets. Any shots striking an overhead baffle will result in a ten-dollar (\$10.00) fine. Failure to report such an incident may jeopardize your registration with the Range.
- \_\_\_ 7. **Handgun caliber ammunition & rim-fire ammunition only on pistol ranges.**
- \_\_\_ 8. **JACKETED AMMUNITION ONLY.** NO lead or cast bullets may be fired at anytime **NO ARMOR PIERCING OR STEEL CORE AMMUNITION ALLOWED.**
- \_\_\_ 9. **RELOADED AMMUNITION WILL BE INSPECTED PRIOR TO USE.**
- \_\_\_ 10. Only Range Ammunition is to used in Range Rental Firearms.
- \_\_\_ 11. Only one person may fire from a booth at a time.
- \_\_\_ 12. **NO RAPID FIRE.** One second rule applies. (1 round per second).
- \_\_\_ 13. **NEVER** cross the firing line or proceed in front of the barriers.
- \_\_\_ 14. **NO** food or beverages are allowed in the Range area.
- \_\_\_ 15. Please remove and dispose of all debris when leaving the Range.
- \_\_\_ 16. Please insure when entering the Range that the outer door is closed prior to opening the inner door. This will help keep the noise out of the lobby.
- \_\_\_ 17. **NO** handling of firearms by customers at anytime except when on the firing line at their assigned shooting position or when assisted by Firing Line Staff. Shooters may trade lanes to try other firearms.
- \_\_\_ 18. Any shooter between the ages of 12 yrs & 18 yrs must be supervised by a parent or guardian and must have proof of completion of a hunters safety or basic firearms class. **NO one under the age of 12 yrs is allowed in the shooting ranges.**
- \_\_\_ 19. **ANYTIME A CEASE FIRE IS CALLED, PLACE YOUR FIREARM ON THE BENCH AND BACK AWAY FROM THE FIRING LINE IMMEDIATELY.** Any shooter is allowed to call a cease-fire for any safety violation, anytime.
- \_\_\_ 20. **FIRING LINE INDOOR GUN RANGE EMPOLYEES HAVE UNQUESTIONABLE AUTHORITY REGARDING THE OPERATIONS OF THE RANGE.**
- \_\_\_ 21. **ALL PISTOL** range rules apply to the use of the **RIFLE** range as well. **NO PISTOLS will be fired on the RIFLE range.**
