VIOLATION OF ANY RULES OR POLICIES MAY RESULT IN THE LOSS OF RANGE PRIVILEGES & REMOVAL FROM THE RANGE PREMISES WHEN DEEMED NECESSARY BY THE RANGE STAFF.

PLEASE READ AND INITIAL EACH OF THE RANGE RULES, MEANING YOU HAVE READ, UNDERSTAND, AND AGREE TO ABIDE BY THEM, THEN SIGN AND DATE AFTER THE LIABILITY RELEASE.

(Initial)

- _____ 1. **ALWAYS** keep the gun pointed in a safe direction. Firearm muzzles must be pointed downrange at all times and never higher or lower than target.
- _____ 2. **ALWAYS** keep your finger off the trigger until you are ready to shoot.
- _____ 3. **ALWAYS** keep the gun unloaded until ready to use. All rental firearms entering and leaving the range area must be **UNLOADED** with actions open and magazines removed showing empty.
- _____ 4. Personal firearms must be **UNLOADED** and cased, or with a current and valid Concealed Pistol License (CPL), holstered and concealed, unless at a designated shooting booth/lane/station within the range.
- _____ 5. Know your target and what is beyond. Un-aimed or uncontrolled fire is strictly prohibited. All shots must be fired at approved targets. Any shots striking the ceiling, walls, overhead baffle, shield, or other non-approved parts of the range, will result in a **\$25.00 fine for each such shot fired**. Failure to report such an incident may jeopardize your registration with the range. **Targets must be no higher than your eye level to avoid hitting our ceiling beyond your target.**
- _____ 6. Report all accidental discharges or malfunctions at once. Keep the gun pointed downrange. At no time may a loaded firearm (with the exception for valid CPL holders) leave the range.
- _____ 7. Know how to use the gun safely.
- _____ 8. Be sure the gun is safe to operate.
- _____ 9. Use only the correct ammunition for your gun. **ONLY JACKETED AMMUNITION ALLOWED** (Exception: rim fire (.22 cal.), shot gun slugs, or with prior permission from Peacemakers Range Staff). No black powder, lead, or cast iron bullets may be fired at any time. **ABSOLUTELY NO ARMOR PIERCING AMMUNITION ALLOWED. Other high power ammo that exceed muzzle velocity limits of 3,600 fps or as determined by range staff, may be disallowed at the discretion of Peacemakers. Absolutely no bird shot, buck shot, skeet/target shot or steel shot allowed. Slugs only in shotgun loads.**
- _____ 10. **RELOADED AMMUNITION MUST HAVE JACKETED BULLETS.** Reloaded ammunition may be inspected prior to use and/or during use on range.
- _____ 11. Ammo for Peacemakers rental guns **MUST** be purchased from Peacemakers.
- _____ 12. All firearms and ammunition on the range are subject to inspection at any time.
- _____ 13. Eye and ear protection **must** be worn upon entry to, departure from, and at all times in the range.

- ____ 14. Drug and alcohol use are each **strictly** prohibited before or while shooting.
- ____ 15. **NO** food or beverages allowed in the range area.
- ____ 16. Only one person may fire from any booth or firing lane at a time.
- ____ 17. Cross lane shooting is **not** permitted from assigned shooting booth or lane.
- ____ 18. **CONTROLLED** rapid fire is allowed. Definition: 2-3 consecutive shots only. You must be on your target.
- ____ 19. **No** drawing to shoot immediately from a holster is permitted.
- ____ 20. **NEVER** cross the firing line or proceed in front of the barriers.
- ____ 21. **DO NOT WALK AROUND THE RANGE WITH A FIREARM IN HAND.** The firearm(s) should be removed from range bags, cases or holsters at, and remain on, the shooting benches in each lane, until holstered or bagged at the shooting bench in each lane.
- ____ 22. Brass may be retrieved from your own area (behind firing line) but only the amount you brought into and used at the range.
- ____ 23. Please remove your targets and dispose all of your debris when leaving the range. If you do not wish to keep your own brass, range officers will collect it, or there will be collection areas for it.
- ____ 24. For the protection of other customers, please insure when entering and exiting the Range that the other door in the range's entry and exit area is closed prior to opening the door. One door open at a time.
- ____ 25. NO handling of any firearms by customers is allowed at any time, except when on the firing line at their assigned shooting booth or lane, or when assisted by Peacemakers staff.
- ____ 26. **Any shooter under the age of 21 for hand guns and 18 for long guns must be supervised by a parent or guardian at all times**, and must have proof of completion of a Hunters Safety or Basic Handgun Course. Minimum age is 12 unless preapproved by Peacemakers staff.
- ____ 27. **ANYTIME A CEASE- FIRE IS CALLED, PLACE YOUR FIREARM ON THE BENCH AND BACK AWAY FROM THE FIRING LINE IMMEDIATELY.** Any shooter is allowed to call a cease-fire for any injury or safety violation, anytime.
- ____ 28. **Proper clothing must be worn** (No bare feet, flip flops, sandals or open foot wear of any kind. Tank tops, low-cut tops, or muscle shirts are not recommended. Long sleeve shirts, pants, and hats or caps, with any long hair pulled back, are recommended for your own protection from hot brass or any other potential exposures.).
- ____ 29. Range fees are non-refundable and non-transferable.
- ____ 30. PEACEMAKERS' employees have unquestionable authority regarding the operations of the range. **RANGE OFFICER OR STAFF DECISIONS ARE FINAL.**
