14. Drug and alcohol use are each <u>strictly</u> prohibited before or while shooting.
15. NO food or beverages allowed in the range area16. Only one person may fire from any booth or firing lane at a time.
17. Cross lane shooting is not permitted from assigned shooting booth or lane.
18. CONTROLLED rapid fire is allowed. Definition: 2-3 consecutive shots only. You must be on your target.
19. No drawing to shoot immediately from a holster is permitted20. NEVER cross the firing line or proceed in front of the barriers.
21. DO NOT WALK AROUND THE RANGE WITH A FIREARM IN HAND. The firearm(s) should be removed
from range bags, cases or holsters at, and remain on, the shooting benches in each lane, until holstered or bagged at the shooting bench in each lane.
22. Brass may be retrieved from your own area (behind firing line) but only the amount you brought into and used at the range.
23. Please remove your targets and dispose all of your debris when leaving the range. If you do not wish to keel your own brass, range officers will collect it, or there will be collection areas for it.
24. For the protection of other customers, please insure when entering and exiting the Range that the other door
in the range's entry and exit area is closed prior to opening the door. One door open at a time.
25. NO handling of any firearms by customers is allowed at any time, except when on the firing line at their assigned shooting booth or lane, or when assisted by Peacemakers staff.
26. Any shooter under the age of 21 for hand guns and 18 for long guns must be supervised by a parent
or guardian at all times, and must have proof of completion of a Hunters Safety or Basic Handgun Course. Minimum age is 12 unless preapproved by Peacemakers staff.
27. ANYTIME A CEASE- FIRE IS CALLED, PLACE YOUR FIREARM ON THE BENCH AND BACK AWAY
FROM THE FIRING LINE IMMEDIATELY. Any shooter is allowed to call a cease-fire for any injury or safety
violation, anytime28. Proper clothing must be worn (No bare feet, flip flops, sandals or open foot wear of any kind. Tank tops,
low-cut tops, or muscle shirts are not recommended. Long sleeve shirts, pants, and hats or caps, with any
long hair pulled back, are recommended for your own protection from hot brass or any other potential
exposures.)29. Range fees are non-refundable and non-transferable.
30. PEACEMAKERS' employees have unquestionable authority regarding the operations of the range. RANGE
